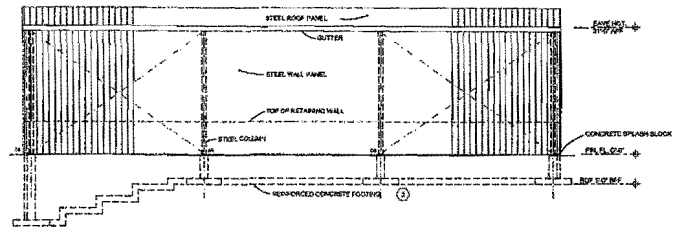

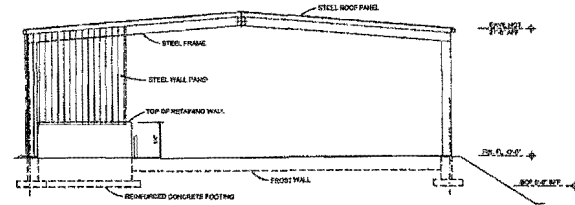
SOUTH ELEVATION

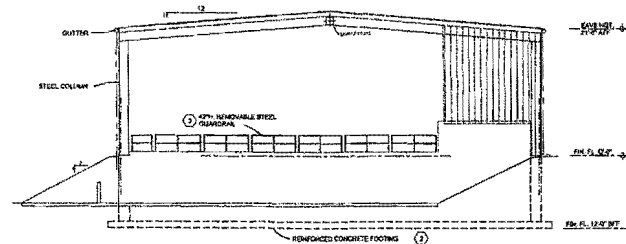
NORTH ELEVATION

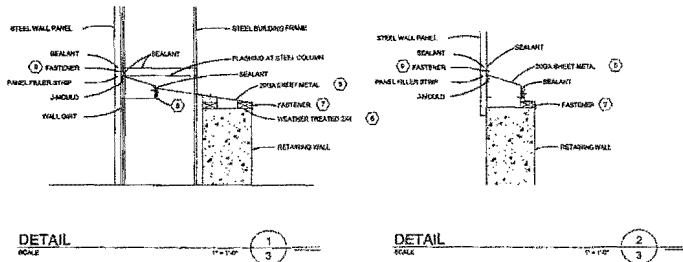
WEST ELEVATION

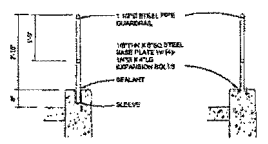

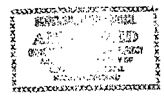

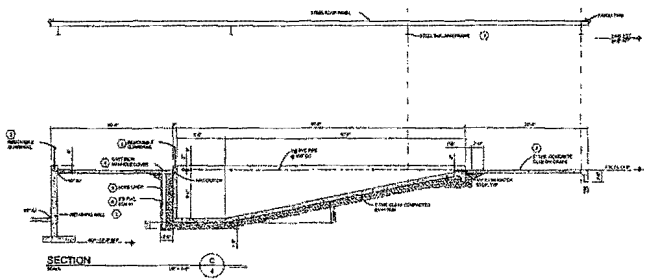
SLUDGE SOLIDIFICATION BUILDING FLOOR PLAN

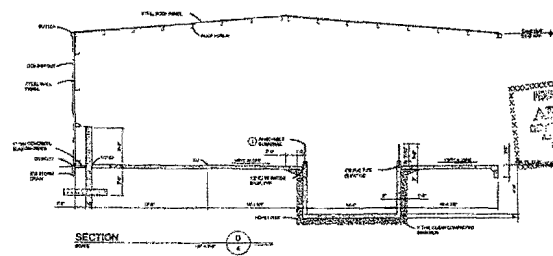
