Items of Note

- Another round of strong thunderstorms will move across regions of the state today and tonight, bringing a heighten flood risk. Many areas are already saturated from recent storms. Thunderstorms today will be capable of producing very heavy rainfall again.
- The National Weather Service confirmed a possible high EF-1 or low EF-2 tornado touched down in Brunswick around 7:00 PM yesterday as a result of severe storms that swept through areas in Ohio. Reports of possible damage to Carol Jane Lake Dam in Medina Township.

Medina County Tornado and Dam

A severe thunderstorm and tornado impacted Medina County on Monday evening. A tornado damaged several homes, uprooted trees, caused power outages, and some other damages. No one was reported injured by the storms and there are no life safety issues at this time.

Heavy rains caused water to overtop the spillway at the Carol Jane Lake Dam. After an assessment by Ohio DNR, there were no immediate concerns for safety of Ohioans and infrastructure downstream. Additional work with the owner continues.

State Actions

Ohio EMA deployed a field liaison last night who will remain through today to support Medina County EMA. Offers of assistance have been made. ODOT was prepared to deploy scene lighting to support emergency responders, though the request was filled by local mutual aid.

Local Actions - Tornado Response and Recovery

Brunswick is addressing site access, debris removal, and law enforcement support of the event. Dumpsters are being coordinated for the residents. No state assistance has been accepted or requested, and no local emergency declaration has been made at this time.

Carol Jane Lake Dam State and Local Actions

Following initial reports of concerns, ODNR conducted an onsite evaluation last night/early this morning to assess dam structure. The assessment indicates that the facility is not at risk of immediate failure. Ohio DNR is communicating with the dam owner on actions to take to maintain the dam and prevent future concerns.

Oil Spill in Trumbull County



 - a) The Division issues a permit to Enviro Tank for the Enviro Tank Facility pursuant to rules promulgated under to R.C. 1509.22(C);
 - b) The Division denies a permit to Enviro Tank for the Enviro Tank Facility pursuant to rules promulgated under R.C. 1509.22(C); or
 - c) Six months after the effective date of rules adopted under R.C. 1509.22(C).
