I found the injection well not operating at the time of my inspection. There was a facility operator on location. The injection tubing gauged over the allowable maximum pressure by 15 psi. The facility operator informed me prior to gauging the injection tubing that the pressure was high. I observed no spills or leaks. Identification signs are posted. There was an AIM Service Co. brine truck on location with the proper identification posted (#25-564). I spoke with the facility operator concerning the over pressure. The facility operator stated:

Inspection.CMMNT:

He shut down the well due to the over pressure.
He was waiting on the well pressure to drop prior to resuming operations.
PAC has been receiving a lot of light water.

I took a Specific Gravity (SG) reading from a port at the injection pump which resulted in 1.13 SG. A follow-up inspection will be conducted.
